New Building Update with Facilities Committee on 2309 N. Broad

- Updates & highlights from Facilities Committee
 - Flynn group was hired last year to assist with the search for a new building. Flynn company, SLT, and Board members decided on 2309 N. Broad as the best possible site for YouthBuild Philadelphia
 - Ballard Spahr is providing pro bono legal counsel throughout this process
 - After comprehensive RFP and review process, Atkin Olshin Schade Architects was the firm chosen for the design of the new school
 - The decision was based on quality of overall proposal, relative performance on Social Identities considerations, understanding and knowledge of YouthBuild, and cost
 - Working towards hiring a project manager to continue moving this process forward and close to signing a contract with Aegis.
 - AOS currently working on Due Diligence phase and design for new building
 - Last year we also engaged with Callowhill Partners as our financial advisors who provided an analysis on how to proceed with financing.
 - Next steps Finance Committee, Facilities Committee, and YouthBuild leadership will be meeting to discuss all financing options and how to move forward with possible 2309 N. Broad site.

- Capital Campaign will be critical competent for financing of this property
- o Board engagement in the process will be critical

AOS Updates

- Sam Olshin, Paul Avazier, and Paul Provenza presented design ideas and renderings for the new space.
- Paul Avazier discusses all the sustainable design practices and strategies AOS is considering for the construction of the building and all the ways the building will be green and sustainable once it is built
- AOS is preparing to meet with Registered Community Organizations (RCOs) to get their approval and support in building a new school in their community.
- March 4th AOS is presenting again for YouthBuild staff for feedback, thoughts, and ideas
- Greenbuild Staff, Student, Alumni Reactions and Group Conversation
 - George Jenkins, GreenBuild (GB) instructor at YouthBuild, and AOS working together to involve current GB students and alumni in the design and future construction of the new building

Capital Campaign Updates

- Renetta Holloway presenting on YouthBuild Campaign and Dunleavy Workflow
 - Phase 1: Assess readiness
 - o Phase 2: Feasibility Study
 - Phase 3: Building the Campaign
- Phase 1:
 - Summarize findings from survey sent to staff and board on Capital Campaign awareness and involvement and what YouthBuild can do to improve in these areas
 - Analysis on trends of donor giving and identify potential and likely donors who will likely contribute to Capital Campaign
 - Analysis on annual fundraising efforts at YB and how it aligns with Capital Campaign
 - Identified 30 new donor prospects who may be willing to contribute
- Phase 2:
 - Results of Feasibility Study was released to YouthBuild
 - First step was to create and test messaging of SOI (Statement of Intent) and to identify and qualify individuals for the study
 - The individuals chosen provided a wide range of stakeholders and were interviewed to assess their connection to youthbuild and its mission, receptivity to the draft SOI, and level of interest in potential support.

- This information is confidential but will be built into the gift pyramid and goal recommendation.
- Dunleavy analyzed the results of the feasibility study and provided recommendations to potentially increase the success of the capital campaign
- Second and third goals of Phase 2 include the Gift Pyramid and Goal Recommendation

Health and Safety Update

- CHOP was selected as the COVID-19 vaccine supplier for all School District personnel. YouthBuild sent information to all staff to schedule an appointment for the vaccine through CHOPs system.
- YouthBuild is also providing two facilitated open spaces for staff and students with Healthcare Professionals. They are providing information about the COVID-19 vaccines and available to answer questions and address concerns
- YouthBuild is currently offering optional and limited in person engagement for students at specific worksites.
- Vaccines are recommended but not required
